1. Sheriffs, assessors, and clerks of court are prohibited from holding any officer employment under a parish governing authority or school board and vice versa.
2. A school teacher or other person employed by in a professional educational capacity in an educational institution or in a parish or city school board may at the same time hold an appointive or elective office.
3. A municipal officer or employee may hold another municipal office or employment such as authorized by R.S. 33:381C. A municipal and/or parochial officer or employee may hold another municipal and/or parochial office or employment if specifically authorized by a legislative or home-rule charter.
4. An elected police juror may be employed as a parish manager or assistant parish manager as authorized by LFA R.S. 33:1236.1
5. Allowed by Act 178 of 2009 Legislative Session for Part Time elected officials.
